UNIT DESCRIPTION

This unit explores a theology, spirituality and practice of missional discipleship. Missional Discipleship aims to deepen students as disciples in the flow between their inner spiritual vitality and outward missional participation in God's work in their communal, vocational and cultural contexts. Key topics include: Biblical and theological foundations for missionally-orientated discipleship and spirituality; discipleship and culture; dispositions and practices to sustain missional spirituality; and practical and relational approaches to evangelism and apologetics, apologetics in a secular society and with people from various world religions, historical approaches to apologetics.

Task Description:

ASSESSMENT TASK 1

Class Discussion Papers on Assigned Readings

30%

Due: Weekly starting week 2

>2000 words

Instructions

Students are to produce 5 papers of >400 words length and deliver them in class for approx. 5 minutes (using a Powerpoint slidepack is optional), with an analysis of key points of the week's assigned reading. During week 1 students will pick which of the 12 possible week's readings they will focus on. This presentation should include the following elements: key points from the reading related to the subject themes, some analytic comments (for example the author's theological relationship to other writers), and 1 or 2 points about the context of the text.

Rationale and Expectations

There are many writings relevant to the topics of Missional Discipleship and Apologetics across 2000 years that need to be understood in context and in relation to other texts. Students are expected to become aware of the breadth of views and their historical and theological contexts.

ASSESSMENT TASK 2

Oral Presentation with supporting text

Due: Week 10 or 11 as arranged.

Students present their missional discipleship formation and apologetics e-portfolio, analysing their engagement with practices for missional discipleship (1000 words) and apologetic engagement with some group (1000 words). (2000 words equivalent)

Instructions

Students are to present in class their missional discipleship formation and apologetics reflection and plan, based on a logically structured and clearly presented written composition that demonstrates engagement with a representative range of the church fathers and scholarly literature, analytical skills in addressing the topic, and insight into their own lived-experience of missional discipleship and apologetics with some selected group (for example Mormons, atheists, Marxists, New Ager, to be agreed with the lecturer). The "reflection" aspect should cover the student's spiritual practices such as prayer and awareness of others' needs, apologetic assumptions and actions as currently practiced, and discussion of areas of weakness in their missional discipleship e.g. consumerism, apathy. The "plan" aspect should cover specific actions undertaken and/or planned for improvement in the areas identified in the reflection section. The e-portfolio can be a powerpoint slidepack or some other presentation, and must accompany text that does not need to be presented as a formal written essay, but should demonstrate knowledge of appropriate sources.

Rationale and Expectations

This subject is somewhat subjective in application but based on solid historical and contemporary principles and examples, thus a self-reflection exercise best captures the individual's current state and growth plans while allowing for freedom and creativity in expression.

ASSESSMENT TASK 3

Oral Exam

30 %

Due: The oral exam will be conducted during Week 13 or 14 at an agreed-upon time.

Equivalent to 1500 words

Note that this is a **Hurdle Assessment**. This means that Students *must* pass this assessment to pass the entire unit.

Instructions

Students will respond to some simple and more complex questions and brief texts related to various aspects of the unit's material, and explain their answers. From Week 1 and during most classes students will be given sample Oral Exam questions and an opportunity to respond to them, with guidance given about the kinds of answers required to achieve each level from Pass to High Distinction.

Rationale and Expectations

Students are expected to understand a wide range of material and be able to reflect on the meaning and practices of missional discipleship and apologetics. In real-life situations they will be required to give answers for their faith in conversation. Having to provide verbal answers at short notice is an excellent real-world assessment and practice for these situations.

Use of AI: No AI generated content is allowed in the final submission for any assignment. Students may:

• Use in-built generative AI to improve the grammar, spelling or other written clarity of their own work.

Students may NOT:

- Use AI to reword their work to the extent of changing their own writing 'voice'.
- Where AI programs are embedded (i.e. Grammarly/CoPilot), students should state the type and extent of AI use in their work at the end of the Bibliography (see Referencing Guides for examples). The student MUST keep a copy of their own original draft (pre-AI involvement) to show if requested.
